Africorp	Swati	SZL 4 445 717.47 (VAT Inclusive)	They did not demonstrate their general experience in so far as the number of years that is required for doing the work in terms of letters and completion certificates nor do they have experience in similar kind of projects as the one to be undertaken. The Project Manager/Site Agent working experience does not meet the requirements. The tenderer has a letter from the bank however it does not commit to avail any amount that we can determine whether their financial standing will enable them to carry out the project. They did not demonstrate whether they have the required equipment to do the works.
Investage Investment	Swati	SZL 4 314 335.42 (VAT Inclusive)	They have demonstrated that they have the experience however their Project Manager/Site Agent does not have the working experience that is required for this project. The tenderer has a letter from the bank however it does not commit to avail any amount that we can determine whether their financial standing will enable them to carry out the project.
